Background and Purpose: New York City (NYC) continues to be an epicenter for HIV transmission in the United States. By the end of 2014, an estimated 119,550 persons in New York City and 4,182 in the Tri-County region (Rockland, Putnam and Westchester counties) have been diagnosed and are presumed to be living with HIV/AIDS.^{1,2} Despite annual declines in new HIV and AIDS diagnosis and significant advances in medical care for people living with HIV/AIDS (PLWHA), disparities in access to health care and in health outcomes persist. Factors associated with poor health outcomes for PLWHA include being of a racial minority, being of a lower socioeconomic status, and being homeless or unstably housed.^{3,4}

Purpose: Since 1991, the federal government has provided emergency relief to areas disproportionately affected by HIV and AIDS through the former Ryan White Comprehensive AIDS Resources Emergency (CARE) Act and now Part A of the Ryan White HIV/AIDS Treatment Extension Act of 2009 (Ryan White HIV/AIDS Program). The New York Ryan White (RW) HIV/AIDS Program includes the five boroughs of New York City and the counties of Westchester, Rockland, and Putnam (Tri-County). The HIV Health and Human Services Planning Council of New York (Planning Council), whose members are appointed by the Mayor, prioritizes service categories and allocates funds.

Awarded organizations are contracted to establish programs that provide HRSA allowable legal services in the New York EMA (New York City and the Tri-County region).
